Associated Press: "Her Husband Pointed A Pistol At Her Head And Said, 'I'm Going To Blow Your F'ing Brains Out.'" "Grossman has said she was long a victim of Walker's impulses. When his book was released, she told ABC News that at one point during their marriage, her husband pointed a pistol at her head and said, 'I'm going to blow your f'ing brains out.' "My name is MARIA TSETTOS. I am competent to make this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct.

"I am the sister of Cindy Walker, Applicant in this case. I know Respondent, Herschel Junior Walker, and have known him in excess of twenty years. I have spoken with Respondent in person on countless occasions and on the telephone on countless occasions. I am familiar with Respondent's voice, and I recognize his voice over the telephone.

On or about September 21, 2005, I was at Applicant's house in Irving, Texas with Christian Walker, the child of this suit. I called Respondent on the telephone, and he became very agitated that Applicant was not with Christian and was out with her boyfriend. Respondent became very threatening, and he stated unequivocally that he was going to shoot my sister Cindy and her boyfriend in the head, or, in Respondent's language, he was going to "blow their heads off."

When Asked To Comment On Walker’s Remarks That There Was “No Exception” In His Mind On Abortion, Walker’s Campaign Said Walker Was “Pro-Life And [Would] Not Apologize For That.” “Georgia Senate candidate and former football star Herschel Walker said Wednesday he supports abortion bans without any exceptions for rape, incest or the health of the mother. ‘There’s no exception in my mind,’ Walker told reporters after a campaign speech. ‘Like I say, I believe in life. Walker, When Asked If He Supported A More Total Ban On Abortion Than Georgia’s Six-Week Prohibition, Said There Was “No Exception” In His Mind And That He Believed In Life. “Herschel Walker, the former football star leading the race for the Republican nomination for a Georgia Senate seat, said that a ban on abortion should have no exceptions — presumably even for rape, incest or the health of the mother. Asked Wednesday if he wanted a more total ban on abortion than the six-week prohibition passed by the Republican-controlled state legislature, Mr. Walker was unequivocal. ‘There’s no exception in my mind,’ he told reporters after a campaign speech in Macon, Ga., at the Georgia Sports Hall of Fame. ‘Like I say, I believe in life. I believe in life.’ He did not single out exceptions for rape, incest or the life of the mother specifically, but he said repeatedly that he wanted no exceptions.” [The New York Times, [5/19/22](#)]
